Certificate of Insurance

As specified in the Bobcat Rental Contract, the Customer assumes full responsibility for all damage, destruction or loss of rental equipment *and* full responsibility for all personal injuries or property damage resulting from Customer's use or possession of said equipment. To this end it is the Customer's responsibility to provide and maintain comprehensive general liability coverage (\$1,000,000 minimum) and have optional coverage for rental equipment (\$75,000 minimum) naming Bobcat of Knoxville / Chattanooga as **loss payee** and **additional insured** with a (10) day notice of cancellation clause. The certificate(s) shall be specifically endorsed to provide that the coverage (as required under this lease) **will be primary** and that any insurance carried by Lessor shall be excess and noncontributory. Please have your insurance company forward a Certificate of Insurance along with this credit application.

Damage Waiver

The Damage Waiver (DW) as offered by Bobcat of Knoxville / Chattanooga is *not* insurance, but will, for a fee of 10% of posted rental rate, waive all claims against you (the Customer) for the first \$500 of damage to the rental equipment. See attached **Damage Waiver Addendum** for details and exceptions. Please *initial below* if the Customer elects to take the DW to help cover any deductible your insurance may have.

Terms

If this application is approved and credit extended to applicant (Customer) by Bobcat of Knoxville/ Chattanooga, than the undersigned agrees to pay according to the terms of payment offered, standard terms being net 10 days. Also Customer agrees to pay service charges of up to one and one half percent per month (18% per annum) should this account become delinquent and to pay all costs of collection, including reasonable attorney's fees and expenses.

Such authorization shall extend to obtaining a credit profile in considering this application and subsequently for the purpose of update, renewal, extension or collecting on the resulting account. A photostat or facsimile copy of this authorization shall be valid as original. By signing below, I/we affirm my/our identity as the respective individuals identified in the above application and I / we **personally guarantee** payment of all amounts owed to Bobcat of Knoxville on this account.

Security Agreement
